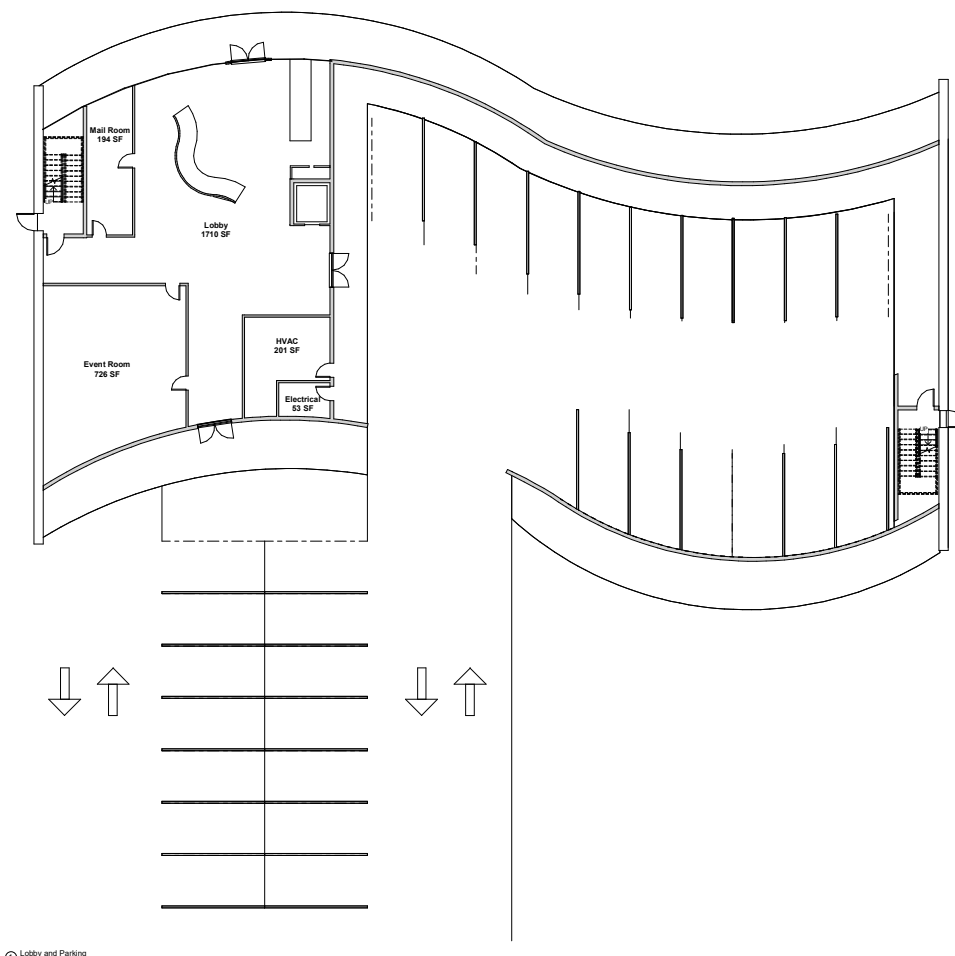

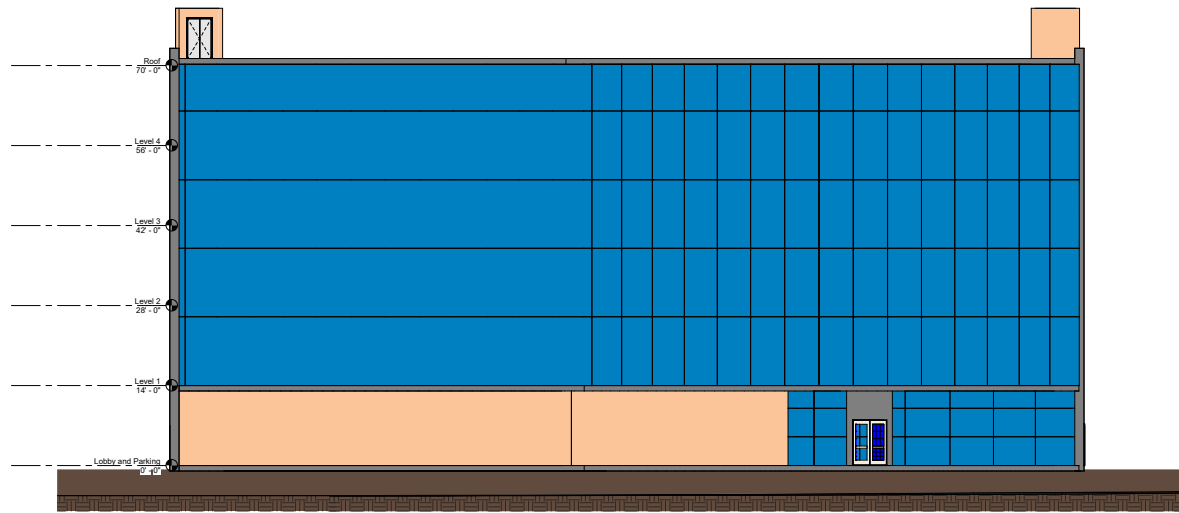

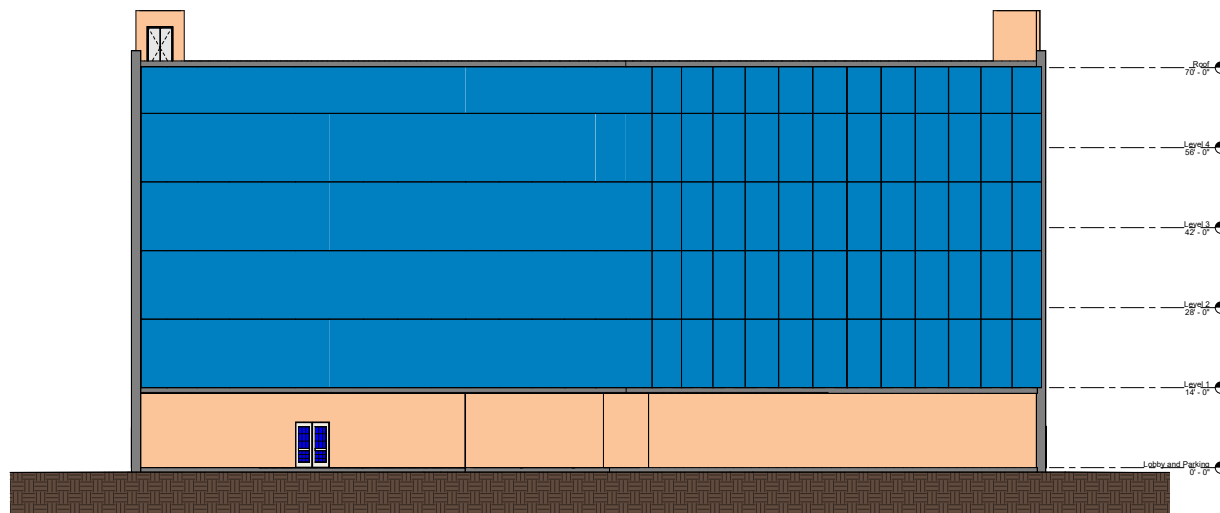

West Section and Elevation

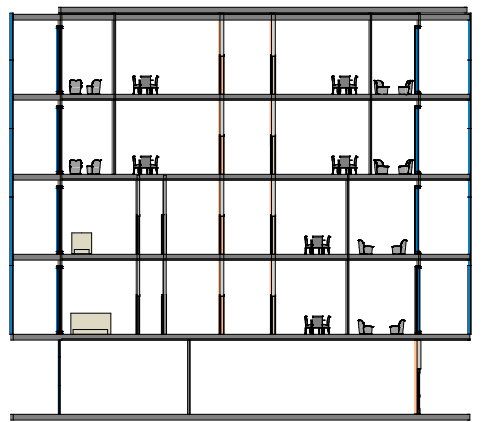

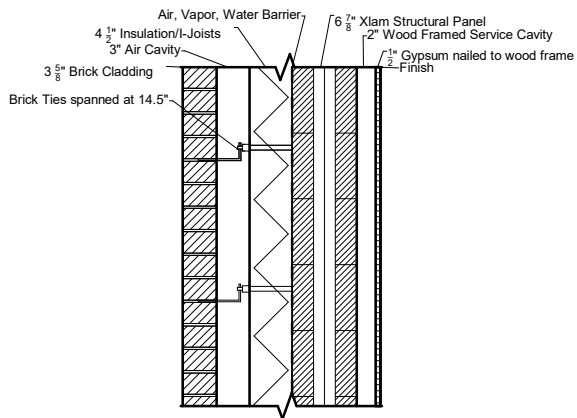

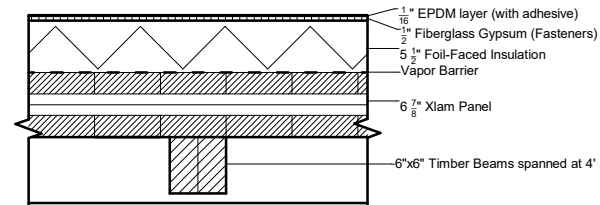
West Elevation

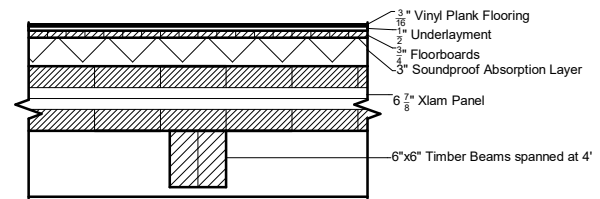
Section 1

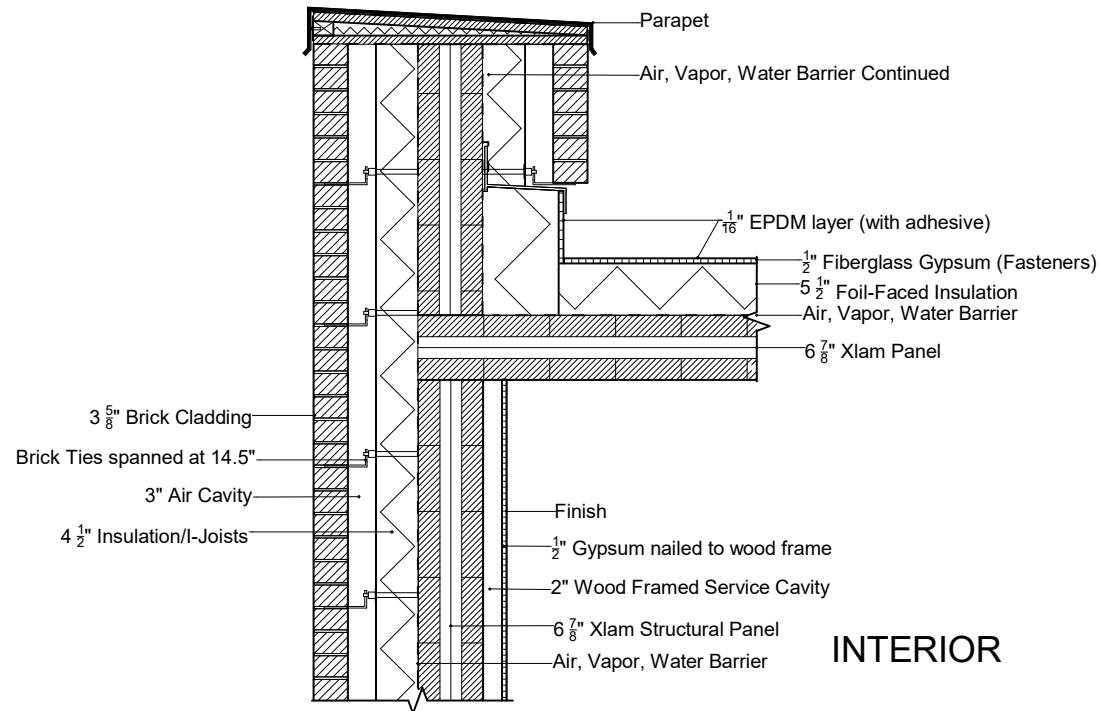

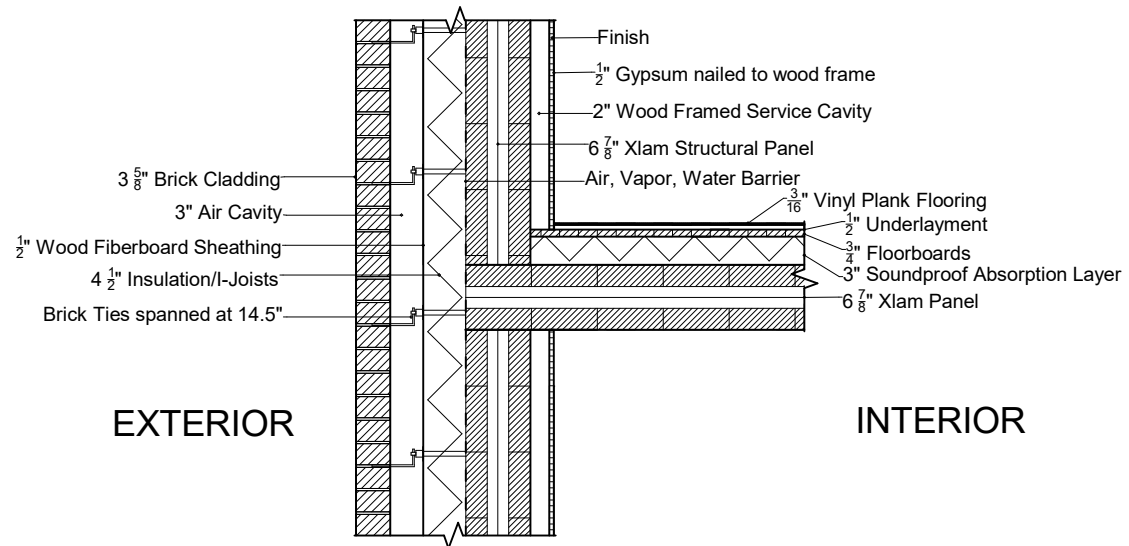

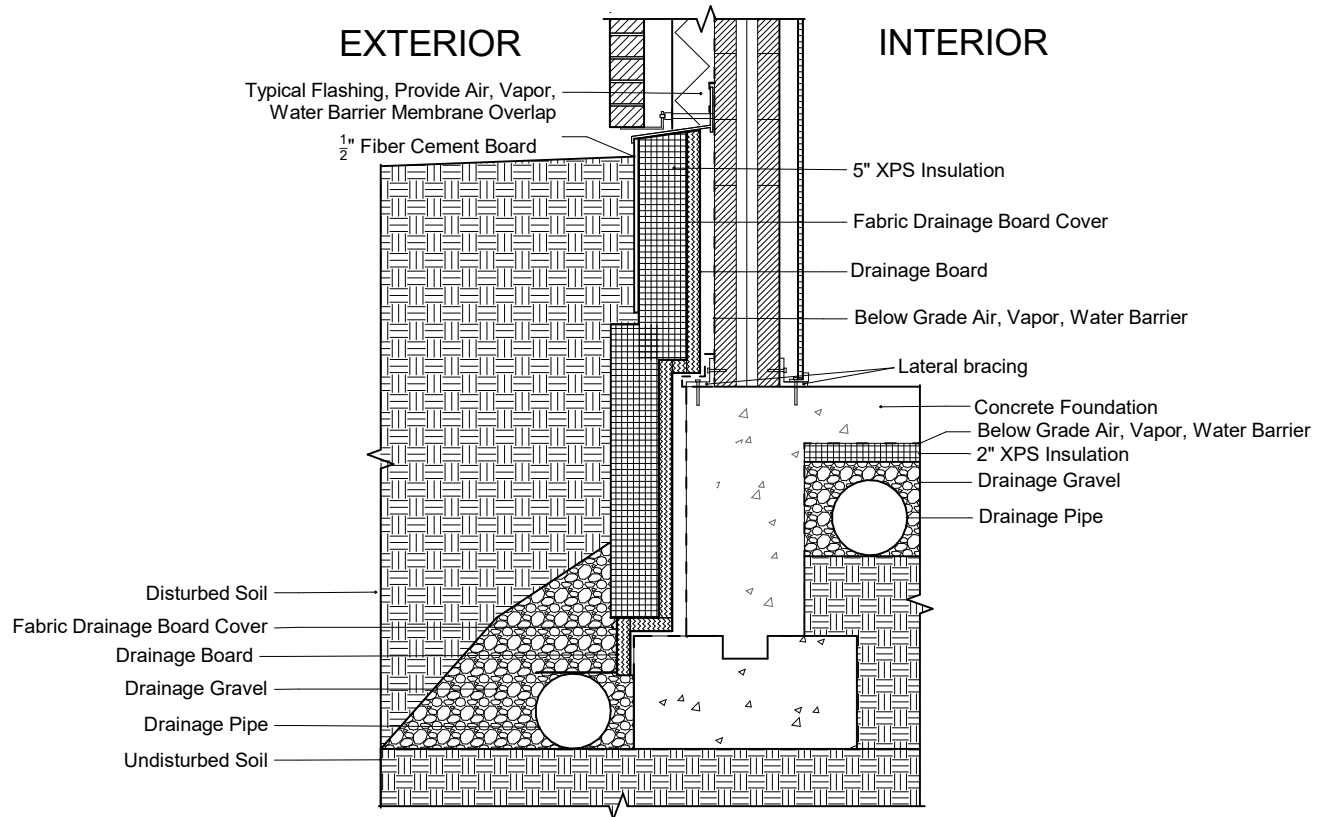
