## PRESIDENT'S MESSAGE...

### STATITROL NOW A DIVISION OF EMERSON ELECTRIC CO...

We are pleased to announce that, effective March 16, 1977, Statitrol Corporation became a Division of Emerson Electric Co., St. Louis, Missouri. Except for changes in our financial reporting and an Emerson Electric identification at the bottom of our literature and stationery, the changes in Statitrol as a result of this merger will be almost invisible. There will be no significant changes in our method of operation, our employee benefit programs, company policy, nor our overall method of operation. The only perceptible change will be with our Board of Directors. In the future, our Officers, together with a vice president of Emerson Electric, will constitute our Board of Directors, or more accurately described as our Management Committee.

Our Profit Sharing Plan will remain exactly as it is unless we decide at a future date to adopt the Emerson pension program. The choice will be ours. The Statitrol stock portion of our Profit Sharing trust, because of our merger with Emerson, will almost triple in value! You will soon see an increase in your Profit Sharing account statement for the Plan Year ending March 31, 1977.

Emerson Electric Co. is a major corporation with sales in excess of \$1.5 billion per year. Even though you will not see the Emerson name on many consumer products, except in rare instances, they are, nevertheless, significantly larger in sales than, for instance, the Johns-Manville Company. Emerson is structured completely different than a typical large corporation in that they act as a banking and management function over a large number of independent corporations such as ours. All of their subsidiaries and divisions operate as autonomous companies. Their home office staff in St. Louis is limited to only about 200 people as compared to approximately 1500 in a typical large corporation.

Many of Emerson's products are sold under different names such as the Sears Craftsman tools, Beard-Poulan chain saws, Rittenhouse intercoms, etc. Please take time to look at one of the copies of the Emerson Annual Statement available in each of our plant cafeterias.

On a personal note, I want to apologize for the fact that newspaper and magazine articles announced our pending merger before I had a legal right to disclose the name of our new parent company. News media can pick up advance information through contacts with the New York Stock Exchange or filings with the Federal Trade Commission. Unfortunately, this information was available to them before our contract was completed. I hope each of you will realize this was not just carelessness, but rather a circumstance beyond my control.

#### FROM OUR SAFETY DEPARTMENT...

The Federal, State and Local Government authorities as well as Insurance Company Regulations require that a company enforce the necessary safety rules to protect all their employees from hazards and injuries. An employer must enforce these safety rules, even to the extent of dismissing those who violate them.

If you are hurt or injured and are required to miss work time, your skills and productivity are a loss to the company. Training new replacements for injured persons is time consuming and costly.

A few simple general rules can reduce our accident rate and prevent many injuries when faithfully observed. Some of these basic fundamental rules are:

1. Safety glasses must be worn at all times while in safety glass areas. Do not remove your glasses while in this area, but wait until you have left before removing them.
2. Keep a clean work station. Good housekeeping is of utmost importance.
3. Keep aisles clear and do not stack boxes, pallets, tables, benches or anything else in a manner in which it might fall.
4. Horseplay in or around the building is strictly forbidden.
5. Use protective clothing when provided and required.
6. Do not override protective switches or use faulty equipment.
7. Report any unsafe equipment or acts to your supervisor.
8. Adhere to special safety regulations which may be part of your job level instructions.

## WHAT IS W.P.S.?

Last May, Statitrol created a Word Processing Station (WPS) under the direction of Reva Atchison. The Wang 1222 word processing equipment was brought in-house after thorough research and study had proven the need for a more effective, efficient way to handle the volume of correspondence from the Marketing Division.

Because Statitrol places a high value on the quality of its products and desires to reflect this professionalism through its customer contacts, we realized the need to upgrade the quality of our correspondence to our customers. Because of the sheer volume of work in some of the marketing areas, particularly Customer Service, it had been necessary to respond to customers with Xerox copies. All customers now receive an originally typed letter.

Carolyn Worden is the Correspondence Secretary responsible for operating the Wang 1222 system. Since the system was initially brought in, it has been handling work primarily for the Marketing Division. A library of cassette tapes of standard letters, etc. has been established for each department using the WPS. The system is also used for applications other than correspondence, i.e., mailing lists, text editing, statistical charts, special mailings, etc.

January proved the need to expand the output capabilities of the WPS to keep pace with the work flow. Even though the WPS produced over 1000 letters, 2000 labels and 60 pages of reports in January, it still could not keep up with the demand for its services. The manufacturer's personnel analyzed the workload of the WPS and recommended their "20 System". The "20 System" is a computerized unit that uses a TV screen to display the material before it is actually typed. After being reviewed on the TV screen, the material is typed automatically on a remote typewriter. This new system will increase output by nearly 100%. The "20 System" types 500 words per minute vs. 190 words per minute on the present system.

The "20 System" is expected to be in-house sometime in April. This system will be budgeted, as time permits, for additional work other than that done for Marketing. We will establish a charge-back system for projects so that each department using the word processing equipment will be charged on the basis of time required to complete projects.

There is no end to the applications for the WPS "20 System" in order to save time and effort. You won't hear the "20 System", or its operator moan over a work project requiring 100 originally typed letters...just the constant hum of efficient machinery and a happy smile from its operator. Stop by and see our new system in operation. If you have any work projects which you feel are appropriate to the system, drop Reva a note to discuss your needs as equipment time permits additional work to be added to the system.

## RECIPE OF THE MONTH: RASPBERRY SALAD

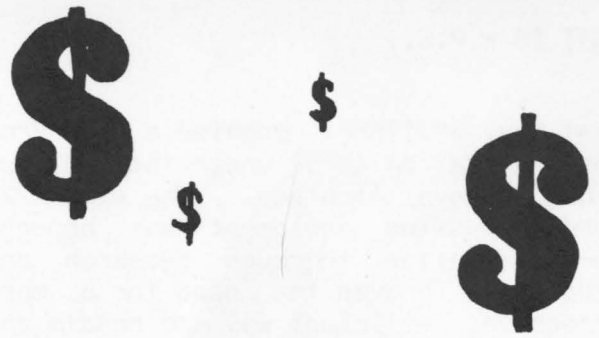
1 package raspberry gelatin  
1 cup boiling water  
1 small can crushed pineapple  
1 banana (mashed)  
1 package frozen raspberries  
1 small carton sour cream

Use juice of thawed raspberries and drained pineapple to make 1 cup. Add this to gelatin and fruit mixture. (Be sure fruit is well drained.)

Pour 1/2 of gelatin mixture into 11 1/2 x 7 1/2" pan or into 8 individual molds. Refrigerate until firmly set. Spread sour cream over mixture. Add the remaining mixture over top of sour cream and let it set firmly. Serves eight.

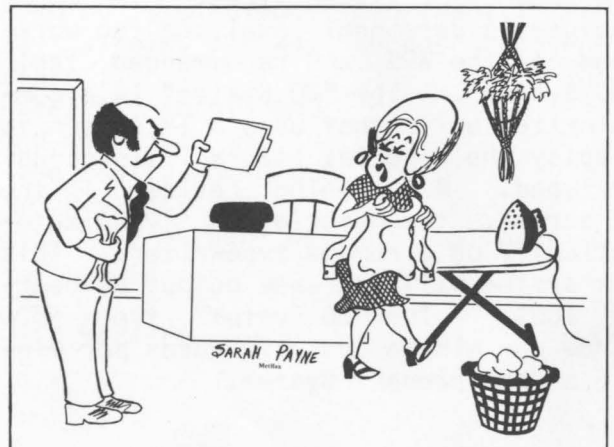
An entry box will be located in each plant cafeteria. Please submit entries no later than April 15, 1977.

## MONEY SAVING TIPS...

When you're waiting to pick up a passenger...do you switch off your engine, or do you let it idle? According to a Ford Motor Company study, a V8 engine burns 1.6 ounces of gas a minute idling vs. only 0.5 ounces of gas restarting while it's still warm. If you idle your engine for just 5 minutes a day while waiting for a friend...or for traffic to clear, it will cost you better than 20 gallons of gasoline in a year. As a rule of thumb, if you're delayed more than a half a minute by an accident, or a dawdling spouse, it's better to turn off your ignition.

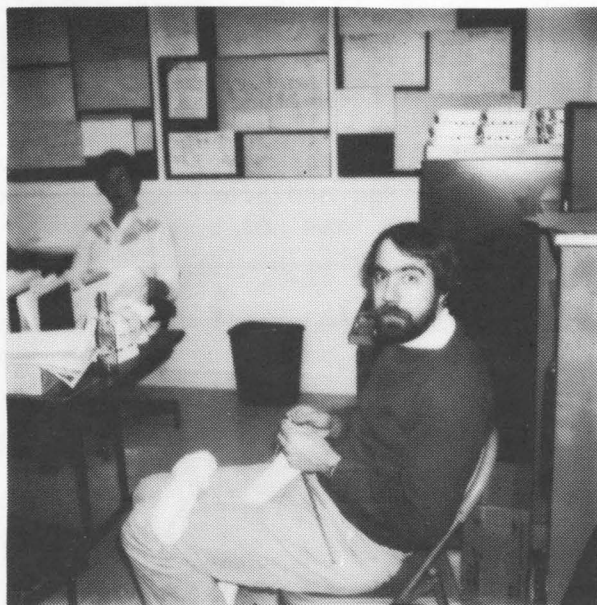
## LETTERS, WE GET LETTERS...
